We want to make Harlow our home

The government has supported plans by Public Health England to create a £400million Science Hub campus at the vacant GSK site in Harlow.

The world-leading centre for public health science will see us relocate a major part of our scientific facilities and our headquarters to the New Frontiers Science Park. Up to 2,750 staff will initially work at the campus, which will be one of the most significant developments in public health research and practice this generation.

Duncan Selbie, our Chief Executive, said: "We want to make Harlow our home and

ensure that the town benefits from having PHE as a neighbour.

"We hope the Science Hub will have a positive impact on the town, providing jobs, training and education opportunities."

The Science Hub will bring together experts in cancer, mental health, diet and nutrition, smoking, alcohol, diabetes, dementia, infectious disease and other long-term illnesses along with environmental hazards and climate change.

During the next stage of the project the initial designs and proposals are being worked up and PHE will then be applying to Harlow Council for planning permission.

As part of that process we are

as widely as possible by giving people the opportunity to send in comments and ideas to help shape the Science Hub plans.

Introducing Public Health England

Public Health England is the expert national body set up by government to protect and improve the nation's health and wellbeing, and reduce inequalities.

Our first duty is to protect people from infectious diseases and other environmental hazards, including chemical and radiological threats. We tackle some of the major challenges of the 21st century. For example, we were part of the international effort to control Ebola in Africa. Staff were on the frontline in Sierra Leone, providing screening at UK ports and undertake vital laboratory research.

To improve health, we provide evidence-based advice about how people can live healthier and longer lives. We work with local authorities and the NHS to prevent long-term illnesses and to make greater progress in tackling our most pressing public health issues. Reducing childhood and adult obesity, preventing type 2 diabetes, helping people make healthy choices, reducing the risk of dementia, ensuring all children get a good start in life and tackling tuberculosis and antimicrobial resistance are priorities.

World-class science underpins all of our work. We use research to find new ways to prevent, diagnose and treat disease, and to respond more effectively when emergencies occur. Our knowledge and intelligence shapes the advice we provide to government and partner organisations as well as the specialist public health services that are delivered by our staff.

We are planning the Science Hub to replace existing laboratories which will become unfit for purpose so we need to replace them before this happens. The new site at Harlow will keep the country at the forefront of public health science.

We expect the Science Hub to take eight years to complete. Our first step is to consult with the Harlow community to help us draw up detailed designs for a new building at the former GSK site. The provisional timetable is:

What will the Science Hub mean for Harlow?

The Science Hub will be a world-class centre of excellence for health protection and improvement. It will combine functions from our existing sites, including our headquarters, and mean we have the latest equipment and technologies. We will work with Harlow Council and other organisations to maximise the benefits from our presence and add to the town's status as a place for cutting-edge science and research.



Education and training

Schools and colleges will be encouraged to visit the campus. Scientists will use a teaching space-**the Eureka Lab**-to give students an insight into their work. We also plan to develop a programme of apprenticeships. Our plans include a large public auditorium for talks, demonstrations and events. We will stage exhibitions for the public throughout the year.



Jobs and investment

Developing the site will inject more than £400m into the economy. Up to 2,750 staff are initially expected to work at the Harlow site, some of whom will be recruited locally. As the headquarters for PHE, the campus will attract visitors from across the world and the UK. The project will boost the local economy, providing extra custom for shops, restaurants and small businesses in the town.



Skilled workforce

We will require a variety of skills to operate a campus on the scale envisaged, including people working in finance, communications, administration, security and other areas. Staff at the campus will include the **best young scientists** and **global experts**. We will provide training and development opportunities so that all our staff can further their careers.



Why Harlow?

Harlow's location in a major life sciences corridor will give our staff **access to some of the UK's best academic, research and commercial expertise**. We work with many partners, including the NHS, local government, charities and voluntary organisations, universities, government and industry. The town's transport links and central location mean the campus will be easily accessible.



Ground-breaking science

The Science Hub will have the **latest equipment and facilities** so we can lead on modern technologies such as genomics and bioinformatics. Open-plan meeting areas will allow scientists to exchange knowledge and ideas.



Government backs PHE's £400m move

The Chancellor George Osborne confirmed in November 2015 that more than £400 million would be invested over an eight-year period to develop world-class facilities for PHE in Harlow.

During the Chancellor's visit to the former GSK site, he said the integrated Science Hub would strengthen the UK's protection against health threats such as Ebola and pandemic flu and keep us at the forefront of public health research.

Under the plans, we will build new facilities to replace the ones we have in Salisbury and North London. The Harlow campus will also act as our headquarters. It is hoped that the campus will be fully operational by 2024 and the first building work will start in 2019.

Harlow MP Robert Halfon described the relocation plans as "the most exciting thing to happen to Harlow in a generation", bringing an initial 2,750 jobs and £400m worth of investment to the town.
