A world-leading campus for Harlow

In 2016, PHE began engaging with the local community and developing plans for PHE Harlow. The creation of this new centre of national and international scientific expertise is critical to ensuring we continue protecting and improving the nation's health. This is of particular significance at the present time as we face the global COVID-19 outbreak.

Four years on, PHE Harlow has outline planning permission, demolition is underway and we're on the verge of submitting the final detailed application.

The 40-acre campus is large enough to co-locate most of PHE's services from Porton, all of those from Colindale, as well as the headquarters in central London. A site of this size will allow PHE to bring together a critical mass of scientists and knowledge that will strengthen research potential and the ability to improve and protect public health.

Whilst PHE Harlow will contribute to protecting public health on a global scale, it will also deliver benefits at a local level and put Harlow on the map for our world-leading public health science.

Before we submit the application, we are keen to share our latest plans with you, as well as the benefits the new campus will offer to Harlow.



Introducing PHE Harlow

PHE is the expert national public health agency that fulfils the Secretary of State's statutory duties in relation to the public's health. PHE's remit is:

- Fulfilling the Secretary of State's duty to protect the public's health from infectious diseases and other hazards to health, working with the NHS, local government and other key partners.
- Securing improvements to the public's health, through its own actions and by supporting government, local authorities and the NHS to secure the greatest gains in health through evidence-based interventions.
- Supporting the development and delivery of efficient, effective and affordable health and care services.
- Ensuring the public health system maintains the capability and capacity to tackle today's public health challenges and is prepared for the emerging challenges of the future.

Four years ago, we announced our intention to relocate our two main laboratories and headquarters to Harlow.

Since then, a huge amount of work has been carried out to make that happen. The next major milestone is on the horizon with the submission of our final planning application for consideration in July.

Throughout those four years, we have worked hard to establish strong and lasting links across Harlow. Today, thanks to an extensive range of engagement and outreach activities, those connections are stronger than ever.

We are committed to providing jobs, training and apprenticeship opportunities for local people to take advantage of.

To that end we have signed memorandums with the Anglia Ruskin, Hertfordshire and Essex universities as well as Harlow College and provided work experience and introductions to science activities for hundreds of school children.

Benefiting Harlow and beyond

PHE Harlow will be a world-class centre of health excellence. We also want to be a big part of Harlow's future and create a campus we can all be proud of.

PHE is working with Harlow Council and many other partners to ensure the benefits from our presence are maximised and add to the town's status as a place for cutting-edge science and research.



Education and training

Schools and colleges will be encouraged to visit the campus. Scientists will use a **community and teaching laboratory** to give students an insight into their work. We also plan to develop a programme of apprenticeships. Our plans include a large public auditorium for talks, demonstrations and events. We will stage exhibitions for the public throughout the year.



Jobs and investment

Developing the campus will make a significant contribution to the economy. **Up to 2,750 roles** will be provided at the Harlow site, many of which will be recruited locally. As the **headquarters for PHE**, it will attract visitors from across the world and the UK. It will also boost the local economy, providing extra custom for shops, restaurants and small businesses in the town.



Skilled workforce

We will require a variety of skills to operate the campus on the scale envisaged, including people working in finance, communications, administration, security and many other areas. Staff will include the **best young scientists** and **global experts**. We will provide training and development opportunities so everyone can further their careers.

Co-location of many of PHE's different scientific capabilities and disciplines is a principal driver for the creation of the PHE Harlow campus.

The modern and flexible facilities will enable easier knowledge sharing and collaboration and, therefore, faster development of innovative science and application to real life health system issues. For example, it allows faster intervention and an increase in productivity to respond to known and novel diseases.

PHE Harlow has been designed with the threat of a novel and pandemic infection in mind. Early learnings from COVID-19 clearly show the importance of an

integrated public health response and the need for rapid sharing of data, information, new laboratory tests and other innovations, co-ordinated and led from centres like Harlow.

These learnings have strengthened the case for the campus which will place Harlow as one part of the public health system for the development and application of a range of public health interventions. These can then be adopted across the country and globally.

The development of PHE Harlow will provide a unique opportunity to deliver a step change in public health capabilities.
