I personally don't smoke, vape or use nicotine, but find the topic very interesting and would make for a good short documentary.

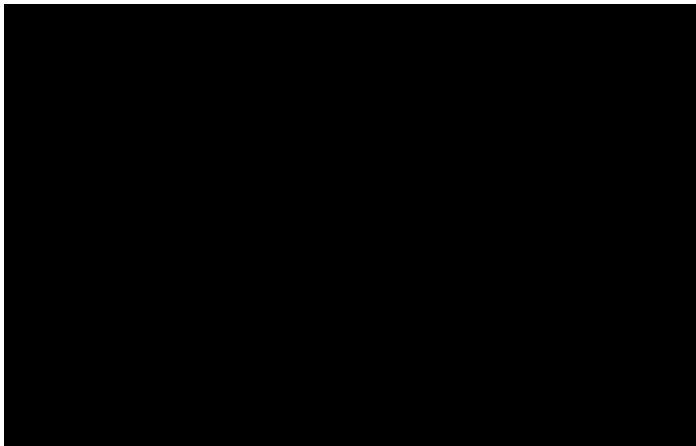
I'm keen to produce something objective, balanced and truthful, to address tobacco harm and the potential for safer and effective methods of quitting.
