







Figure 5: Prevalence of experience of dental decay in 5-year-olds in the West Midlands, by ethnic group.




Figure 6. Prevalence of experience of dental decay in 5-year-olds in Warwickshire, by lower-tier local authority.




Figure 7: Prevalence of experience of dental decay in 5-year-olds in North Warwickshire, by middle super output area.






Figure 8: Prevalence of experience of dental decay in 5-year-olds in Nuneaton and Bedworth, by Ward.





Summary

In Warwickshire average levels of dental decay are lower than the average for England, however, within Warwickshire there are areas where there are higher than average levels of experience of dental decay. At lower-tier local authority level, children living in Nuneaton & Bedworth have the highest levels of experience of dental decay. Within Warwickshire, the highest levels of experience of dental decay are clustered around the wards of Camp Hill and Abbey (Nuneaton and Bedworth LA) and Benn (Rugby LA).

The small sample size means it is not possible to provide information at ward level for all areas. Future surveys could be commissioned to provide larger samples to facilitate local analysis. Commissioning High Quality Information to Support Oral Health Improvement: A toolkit about dental epidemiology for local authorities, commissioners and partners is available to support the commissioning of oral health surveys⁴.

Public health interventions can improve child oral health at a local level. Local authorities improving oral health: commissioning better oral health for children and young people is available to support local authorities to commission oral health improvement programmes for children and young people aged up to 19 years⁵.
