# Summary of Discussion: UKHSA Data Science Advisory Board 24<sup>th</sup> June 2022 14:00-15:30 [held virtually]

## Chair: Sylvia Richardson

# 1. Welcome

- Apologies were noted from: Dr Johanna Hutchinson (UKHSA) and Professor Ewan Birney (EMBL- EBI).
- Board noted that previous minutes (25.02.22) had been formally approved prior to this meeting.
- Noted that E2E (end to end) is be added to the agenda of future meetings to progress discussion, and that the accreditation that the "new" profession of data scientists could credibly follow.

# 2. DSAB review

Summary of the DSAB review results given by Anna Seale, followed by discussion.

- DSAB provides a useful external view for Data, Analytics and Surveillance (DAS) in UKHSA.
- Bringing strategies under development would enable expert input.
- Other key topics for advice could include quality assurance, and how data science is being implemented operationally.
- The duration of DSAB has been limiting discussion, and the meetings should be extended, but held less frequently, with extraordinary meetings held when requested by the Secretariat.
- Follow-up on discussions should be provided through an update from UKHSA as a standing agenda item.

# 3. Revisit DSAB Terms of Reference (ToR)

Summary of the current DSAB ToR given by Anna Seale, head of DSAB Secretariat, followed by discussion.

- The ToR requires redrafting, as it was written for the Joint Biosecurity Centre and does not reflect the current organisational structures and requirements.
- It was noted that in practical terms the revised ToR should:
  - Summarise the role of UKHSA and its structures.
  - Clarify the purpose of DSAB and who it advises, and how this relates to other governance structures in UKHSA.
  - Update on roles and responsibilities, reflecting the DSAB review and discussion on this.
  - Consider the DSAB membership in view of the roles and responsibilities in the ToR.
  - $\circ$   $\;$  Note that documents are needed in advance of the meeting.
  - Meetings to be quarterly, and review rotation of the chair.

## 4. Geospatial Strategy Presentation

Presentation by James Lewis, Lead of geospatial team, UK Health Security Agency (UKHSA).

- Spoke about the approach to geospatial work at UKHSA, aiming to develop a centralised service and capability, integrated across UKHSA
- Highlighted the partnership work informing the development of the geospatial unified approach, and engagement across UKHSA Groups (Clinical Public Health, Science, Health Protection Operations, Technology and Strategy).
- Noted that the aim is to have a coordinated approach, working collaboratively internally but also with academic, xHMG and commercial partners externally, to build capability which manages reference data, provides analytics and visualisation support to add value.

## 5. Discussion

A constructive, engaging discussion on the Geospatial Strategy presentation took place and centred on the following key points:

- Defining geospatial standards important.
- Interoperability should be considered.
- Data pipelines should be appropriate, and consider weather and climate data.
- Appropriate external stakeholders to engage with should be identified through mapping.
