## The Delivering Fair Dementia Care For People With Advanced Dementia Report

The Fair Dementia Care Commission, established by Alzheimer Scotland, published the 'Delivering Fair Dementia Care For People With Advanced Dementia' report.

The report sets out a firm definition for advanced dementia for the first time. It also identifies the inequality people living with advanced dementia face in terms of access to health care. Through the report the Fair Dementia Care Commission calls for a number of reforms, including equal access to free healthcare for people living with advanced dementia.

#### **Covid booster vaccines**

The JCVI issued their final advice a few weeks ago regarding the Autumn Covid Booster.

The following groups will be offered an additional dose of the Covid booster in a community clinic from September:

- Residents in a care home for older adults and staff working in care homes for older adults.
- Frontline health and social care workers
- All adults aged 50 years and over.
- Those aged 5 to 49 years in a clinical risk group, including pregnant women.
- Those aged 5 to 49 years who are household contacts of people with immunosuppression.
- Carers aged 16-49 years.

Its likely that carers will be called for the boosters around Dec time and there will be a similar booking process to previous vaccine rollouts for carers (I.e. online portal / national booking line).

There will be further info around this in the coming weeks which we will share as and when we receive it.

#### Care and Repair Edinburgh Fire Alarm installations - Hardship Funding

The new interlinked fire alarm legislation was introduced in Scotland in February 2022.

Scottish Government have awarded Care and Repair Edinburgh (CRE) funding to assist lower income older and/or disabled homeowners fulfil this legislative requirement.

To be eligible for support, applicants must comply with all the following criteria:

- Live and own their home that has a Council Tax banding of A-C (Band D may be considered)
- Be of either state pension age and in receipt of <u>guaranteed</u> Pension Credit or have a disability and be in a <u>support group</u> for Employment and Support Allowance. Applicants must provide the appropriate reference number to CRE
- There should be no other earning adult in the household including another person in receipt of state pension or ESA unless they are also on Pension Credit or in a support group ESA.

As well as assisting with the installation of interlinked fire alarms through this fund, CRE are also offering this service to anyone over the age of 60 or who lives with a disability within the city of Edinburgh.

The cost of this service is £236 for a single storey property (2 smoke + 1 heat alarm) or £290 for a double storey property (3 smoke + 1 heat alarm). This is payable in advance of fitting by cheque, cash or bank transfer.

Additional alarms are charged for at unit price.

CO alarms are supplied if required free of charge through funding from Scottish Gas Network
